*peppa – the intercultural Girls Centre is located in the 16th district in Vienna. Most of the girls and young woman, who visit *peppa are living in the district or attend school nearby. The 16th districkt, called Ottakring, is located west of the central districkts of Vienna. Over 20 % of its population has migrational background.

*peppa is situated in a residential area, with shopping streets, parks, schools and recretional facilities nerby.

Volunteers will be placed directly in the Girls Centre, but will also take part inorganised outdoor and cultural activities. This projekt is coordinated by Grenzenlos, which means that the volunteer will bei integrated in the MELANGE-programm, the EVS in Vienna in cooperation with the city of Vienna/wienXtra. This means that she will have the opportunity to meet 25 other foreign ERVS volunteers as well as Austrian returnees. All volunteers will be offered a leisure time programm, in order to get to know specifics aboaut the Austrian and Viennese culture. There are monthly meetings in order to offer continuous follow-up of the volunteers and to offer a sockal event where current future and former colunteers can meet. Grenzenlos also organizes housing, helps with finding language courses for the volunteers and offers a mentoring programmm as well as help with all administrative matters.

Volunteers of *peppa get the opportunity to work with girls and young woman form different cultural, religious and social backgrounds.

Volunteers will be able to get insights into the life of immigrant girls in Vienna, appreciate and value different culturels and customs and are able to gain expereience in emancipatory and partial workt with girls and young women.

Volunteers of *peppa will be involved in the organisation and realisation of leisure activities, in- and outdoor as well as excurisons. Furthermore, they will assist qualified members of *peppa during study support sessions. They are welcome to accompany the staff of *peppa and participiate in discussions and discussions and activities in the daily Girls Café. Volunteers are welcome to bring their own ideas into the work of *peppa.

Volunteers of *peppa will be valued members of the team and participate in the weekly team-meetings.

A typical day could look like this:

13:00-15:00 Girl's Café / Lunch Special

15:00-17:00 Girl's Café / Learning Aid

17:00-19:00 Girl's Café / Workshop

As beeing part of the MELANGE programm volunteers are invited to take part in free time activities together with other EVS volunteers in Vienna. Also aditional workshops are offered by Grenzenlos on the topic inclusion, theater etc. EVS volunteers are also invited to probes their own acitvities.

*peppa is a project for girls and young women only. Because of this specific nature *peppa – volunteers need to be female. They are required to show an interest in partial and emancipatory work with girls and young women als well as different cultures, customs and social backgrouns. Because of the responsibility and sensibility that is required in the work of *peppa, volunteers need to be 20 years and above.

*peppa invites interested volunteers to introduce themselves via email and include their motivation and expectations regarding their placement at *peppa – the Intercultural Girls Centre. *pepa will choose suitable canditates in a transparent and open process involving all members of the team and including phone conversations with the applicants.

Regular formal and non-formal meetings with the staff of Grenzenlos who coordinates the melange programm and the project mentor are planned.

Grenzenlos staff will intervene and provide support and deal with crisis management with both the volunteer and host organisation and will in turn report, if necessary, will liase with the volunteer's family.

The volunteers will be provided a emergency phone through which, in case of emergency, the Staff of Grenzenlos can be reached.

Furthermore she will receive the contact of the mentor. *peppa staff will of course instruct the volunteer on whom to contact of the staff in case of emergency, escape routes will be shown. First Aid as wee as Fire and Safety Trainings are provided to all staff. In order to prevent risks, *peppa is committed to provide a safe working environment to its staff as well as volunteers. It follows the safety standards required by the Caritas Archdiocese Vienna.

*peppa does not host a volunteer aged under 20.

Besides physical health and safety, *peppa is concerned with the psycho-social well being of its members of staff as well as volunteers. Therefore volunteers will be involved in regular team meetings and participate in supervision-sessions.
